Saint Lucia is a sovereign island nation in the Eastern Caribbean Sea. It is an island of the Lesser Antilles belonging to the Commonwealth. Saint Lucia is known for its tropical climate, unique natural scenery with breathtaking mountain panoramas and lush rain forests.

Saint Lucia is a member of the African, Caribbean and Pacific Group of States, the Commonwealth, Caribbean Community, Organisation of Eastern Caribbean States, Organization of American States, United Nations and World Trade Organization.

### TRAVEL WITH EASE

As a citizen of Saint Lucia, you gain access to visa-free travel to over 147 countries, including all Schengen states, the United Kingdom, most British Commonwealth member countries and Latin America, making a citizenship in Saint Lucia an extremely attractive choice.

Furthermore, with your Saint Lucia passport, obtaining most foreign visas for you, your spouse, dependent children and parents will be a smooth and easy process.

### TAKE ADVANTAGE OF NEW BUSINESS OPPORTUNITIES

Saint Lucia passport holders benefit from an attractive tax regime:

No wealth, gift, inheritance, foreign income, or capital gains tax, as well as no personal income tax. Furthermore, you will have access to generous incentive packages including corporate tax incentives, full exemption from import duties, tax relief benefits and export allowances.

Saint Lucia ranks 93<sup>rd</sup> in the 'Doing Business Report' by the World Bank.

### SECURE YOUR FAMILY'S FUTURE

Your spouse, dependent children below the age of 30, dependent parents over the age of 55 and siblings of the main applicant below the age of 18 can apply to obtain their Saint Lucia passports along with you, and will be able to enjoy life on one of the most developed islands in the Caribbean, with excellent access to healthcare services all over the island.

You and your family are not required to live in Saint Lucia to obtain citizenship, meaning you can apply for and receive secondary passports without having to relocate the entire family or renounce your original nationality.

## INVESTMENT OPTIONS

There are 3 investment options which serve as a qualifier for the application to the Saint Lucia citizenship-by-investment programme:

### OPTION 1

#### National Economic Fund (NEF) Contribution

- Main applicant: **USD 100,000.**
- Main applicant and spouse: **USD 140,000.**
- Family of up to 4: **USD 150,000.**
- Each additional dependent: **USD 25,000.**

**(Contribution is non-refundable).**

### OPTION 2

#### Real Estate Investment

- Minimum investment in an approved real estate project: **USD 300,000.**

### OPTION 3

#### Covid-19 Relief Bond Investment

**USD 250,000**

- Single applicant: 5-year holding period.
- Applicant and 1 dependent: 6-year holding period + **USD 15,000** per additional dependent (up to 4 dependents).
- Applicant with up to 4 dependents: 7-year holding period.

**USD 300,000**

- Applicant with up to 4 dependents: 5-year holding period.

- **Additional government fees apply.**

## PROCESS AND TIMELINE

**Month 1 Preparation** Sign a retainer agreement for Next Generation Equity to act as your legal advisor for the application and legal process.

Prepare required documentation.

Payment of government fees, due diligence, citizenship application and legal fees.

Submission of the citizenship application.

**Month 2-3 Citizenship application** Government due diligence process.

Citizenship approval is issued.

**Month 4 Receive citizenship** Upon receiving your citizenship approval, you can continue with your selected investment option:

- Make the National Economic Fund (NEF) contribution. The payment will be made directly to the government.
- Proceed with the complete purchase of real estate. The payment will be made directly to the developer's escrow account.
- Make the Covid-19 Relief Bond investment. The payment will be made directly to the government.

Take Oath of Allegiance.

Citizenship Certificate of Registration is issued.

Saint Lucia passport is granted thereafter.

\* The time estimated to receive the citizenship approval is based on the government's due diligence processing time and may vary.
