## ABOUT ANTIGUA AND BARBUDA

Antigua and Barbuda is an independent Commonwealth state in the Eastern Caribbean. With some 365 beaches of clean turquoise waters, the lush tropical islands of Antigua and Barbuda are an inviting paradise and considered to be one of the most beautiful places in the world. As a result, tourism is the key driver of Gross Domestic Product (GDP) and generates around 60% of the island's income, with key target markets being the U.S., Canada and Europe.

Antigua and Barbuda is a member of the United Nations, the British Commonwealth, CARICOM and the Organisation of American States (OAS) among many other international organisations.

### TRAVEL WITH EASE

The Antigua passport unlocks visa-free travel to over 140 countries including Hong Kong, Singapore, the UK and the Schengen states.

The passport is valid for a period of 5 years and will be considered for renewal subject to the recipient having spent a total of 5 days in Antigua and Barbuda since gaining citizenship.

### TAKE ADVANTAGE OF NEW BUSINESS OPPORTUNITIES

Antiguan passport holders benefit from important tax advantages, such as no capital gains tax or estate tax and no taxation on worldwide income. Antigua has a currency that is fixed to USD and duty free trading throughout the Caribbean.

### SECURE YOUR FAMILY'S FUTURE

Spouse, children and elderly parents can apply to obtain their Antiguan passports along with you and will be able to enjoy a high quality of living in one of the world's top 20 islands.

## INVESTMENT OPTIONS

There are two investment options which serve as a qualifier for your application to the Antigua and Barbuda citizenship-by-investment programme:

### OPTION 1

#### National Development Fund (NDF) Contribution

- Main applicant or a family of up to 4: **USD 100,000.**
- For a family of 5 or more: **USD 125,000.**

### OPTION 2

#### Real Estate Investment

- Approved property: **USD 200,000 or 400,000.**

## GOVERNMENT FEES

#### NDF:

- Family up to 4: **USD 25,000.**
- Each additional dependant: **USD 15,000.**

#### Real Estate:

- Family up to 4: **USD 50,000.**
- Each additional dependant: **USD 15,000.**

## PROCESS AND TIMELINE

**Month 1-2 Preparation** Sign a retainer agreement and pay the first retainer invoice.

Prepare required documentation.

10% payment of government fees.

Payment of due diligence and citizenship file fees.

Submit citizenship file.

**Month 3-4 Citizenship application** Receive an approval letter from the Citizenship-by-Investment Unit.

Payment of remaining government fees.

Select your preferred investment option:

- The National Development Fund donation fees will be paid directly to the government.
- The Real estate investment will be paid directly to the developer's escrow account.

**Month 5-6 Receive Antiguan citizenship** Citizenship Certificate of Naturalisation is issued. Passport is granted thereafter.

\* The time estimated to receive the citizenship approval is based on the government's due diligence processing time and may vary.
