Saint Kitts and Nevis is an island country in the West Indies and is the smallest sovereign state in the Western Hemisphere. The country is a Commonwealth realm, with Queen Elizabeth II as head of state. The Saint Kitts and Nevis Citizenship by Investment Programme was established in 1984, making it the oldest programme of this kind in the world. Since then, the country has continued to lead the economic citizenship industry, and has made it its goal to represent the 'Platinum Standard' of citizenship by investment. Today, the Saint Kitts and Nevis Programme stands as the oldest, most trusted, and most successful programme of its kind.

Travel with Ease

As a citizen of Saint Kitts and Nevis, you gain access to visa free travel to 141 countries, with more countries being constantly added to the list, including all countries in the Schengen area as well as major countries in Latin America, North America and Asia. Should you travel anywhere outside these countries, the Saint Kitts and Nevis passport will facilitate and smoothen the process of obtaining a visa in most countries.

Take Advantage of New Business Opportunities

Saint Kitts and Nevis passport holders benefit from an attractive tax regime:

No foreign income, wealth, gift, inheritance, or capital gains tax if non-resident.

Furthermore, the benefits include tax free trade with Canada and duty free trading in the whole of the Caribbean.

Saint Kitts and Nevis 60 Day Accelerated Process

The Accelerated Application Process (AAP) approved by the Government of Saint Kitts and Nevis in October 2016 allows applications with the Citizenship by Investment Program to be accelerated to a 60 day processing period. Applying using the AAP can see an application completed within 60 days with some applications completed in as early as 45 days.

AAP Process Fees (inclusive of due diligence fees)

- Main Applicant: **US \$25,000.00**
- Dependant >16 years of age: **US \$20,000.00**

INVESTMENT OPTIONS

There are two different investment options, which serve as a qualifier for your application to the Saint Kitts and Nevis citizenship program.

OPTION 1

Monetary contribution to the **Sustainable Growth Fund (SGF)** plus government processing fees and due diligence fees:

- For a single applicant: **US \$150,000** non-refundable
- For a family of up to 4: **US \$195,000** non-refundable
- For each additional dependant, regardless of **US \$10,000** (non-refundable) applies.

OPTION 2

Investment in pre-approved real estate projects, which can include hotel shares, villas and condos:

- **US \$200,000** minimum investment (resalable after 7 years)
- **US \$400,000** (resalable after 5 years)

STEPS AND PROCEDURES

Month 1 Client signs retainer agreement and pays the first retainer invoice.

Client collects documentation for application until file is ready for submission.

10% payment of government fees, due diligence fees and citizenship application.

Client pays submission invoice of advisory and legal fees.

Month 2 Next Generation Equity receives client's due diligence results and citizenship approval is issued.

The remaining balance of government fees is paid directly to Next Generation Equity which will be paid to the government. The Sustainable Growth Fund donation fees will be paid directly to the government bank account.

In the case of a real estate investment, the investment is paid directly into the government escrow account.

Client pays the approval invoice of Next Generation Equity Advisory and legal fees.

Month 3 Citizenship Certificate of Naturalization is issued and Next Generation Equity obtains client's passport.

Passport can either be picked up in Next Generation Equity's office or delivered to client's home address.

* The time estimated to receive the citizenship approval is based on the government's due diligence processing time and is not guaranteed.
